Aloha Ho'olei Homeowners:

In order to facilitate your upcoming move, we have interviewed a number of local moving companies. Each company has undergone a screening process to acquaint them with the special requirements of this beautiful property. Representatives from these companies have agreed to stringent move-in procedures (see enclosed copy of the Memorandum), designed to safeguard the Ho'olei AOA common property and limit the move-in disruption to residents.

Only moving companies which have undergone this process, signed this Memorandum and been approved by the Residence Manager and Managing Agent may have access to the property. The following companies have indicated their willingness to work with Ho'olei to ensure that your move is handled professionally. They would be happy to quote their rates and differing services.

If you wish to use a company not on this list, have their representative contact us and we will go through the assessment procedures with them.

Notwithstanding the enclosed Memorandum, owners will be held responsible by the Ho'olei AOA for any damage incurred by their movers to any common areas. Therefore, all owners are required to hold Ho'olei AOA, MF-9 and Associates and their assigns harmless from any liability or damage to goods, buildings or persons. You or your authorized representative will need to be present to verify the arrival and condition of your goods and the condition of your premises, and to sign a release that you or your representative are responsible for any damage caused by your move.

Please note that only one moving company will have access to your building at one time, so it is imperative that you and your moving company coordinate your moving date and time with the Residence Manager at (808) 357-1216. ***Please note that working hours are limited from 8:00 a.m. to 5:00 p.m. Monday through Friday. There will be a (\$100) fine per hour fee assessed if work continues past 5:00 p.m. or must be scheduled on Saturday.;***

If you're planning to ship your goods by container, it's advisable to consign your shipment "In Care Of" the Maui moving company you choose. Your movers will then be contacted as soon as the container arrives. **Any containers brought to the property must be reserved with the Residence Manager and removed on the same day that they arrive. Owners will be fined \$500/day if a container is not removed the same day.**
